Sutrisno A. Tampubolon, SH. No. 53 dated September 27<sup>th</sup>, 2002.

In addition to serving as the Company's President Director, he currently also held the positions as the President Commissioner of Company's subsidiaries, PT Kalimantan Powerindo, since February 19<sup>th</sup>, 2013, PT Nityasa Prima since October 2007 and also as Commissioner of PT Suli Inti Resource since October 2010.
